- Income-based Jobseekers Allowance (not Contribution Based Jobseekers Allowance)
- Income-related Employment and Support Allowance (not Contribution Based Employment & Support Allowance)
- Support under Part VI of the Immigration and Asylum Act 1999
- the guaranteed element of State Pension Credit
- Child Tax Credit (provided you're not also entitled to Working Tax Credit and have an annual gross income of no more than £16,190)
- Working Tax Credit run-on - paid for 4 weeks after you stop qualifying for Working Tax Credit
- Universal Credit, during its initial roll out

Children who get any of the above benefits in their own right (ie they get benefits payments directly, instead of through a parent or guardian) can also get free school meals.

You may be able to get free school meals for children who are under the compulsory school age and in full-time education.
